PRESENTATIONS AT AAMFT CONFERENCE

Five of our AAFT members were invited to share their expertise at the AAMFT conference, "2019 Institutes for Advanced Clinical Education in Singapore", which was held right after the AAFT 7th conference in Batam Island. Topics included "Social Withdrawal of Today's Youth in Asia: Culture and Family Perspectives" by Dr Takeshi Tamura, "Capturing Children's Response to Parental Conflict and Making Use of It" by Drs Irene Kam and Viviana Cheng, and "The Sweat and Tears in Differentiating from Asian Parents: Reflections on Stories of Taiwan Families" by Dr Wentao Chao. This was a great example of how the clinical work in Asia is gaining momentum in the West. We hope that more collaborations like these can happen in the future.

FAMILY THERAPY AND SOCIAL DISTANCING

The Accreditation Committee, which is chaired by Dr Shinichi Nakamura, has been actively working on polishing and finalizing our Accreditation procedures and standards. The updated accreditation criteria will be much more comprehensive. INTERNATIONAL COLLABORATIONS

Dr Wai-Yung Lee had been invited to deliver a keynote at the Australia Association of Family Therapy annual conference in September 2020, following Dr Takeshi Tamura's keynote presentation in September 2019. Again, the conference had also been postponed to September 9-10, 2021 due to the virus.

Dr Tamura had also taken up the lead to publish a special issue on Asian family therapy for the Australian and New Zealand Journal of Family Therapy, which will be published in 2021. We are looking forward to reading it!

A cross-regional project had been formed to collaborate on the *Capturing Children's Response to Parental Conflicts* model developed by Dr Wai-Yung Lee and her team. This newly established project, which includes participants from France, Sweden, Japan, Korea, Shanghai, and Taiwan, is another joint venture at an international level. Regrettably, the meeting had been postponed several times due to the pandemic. Like many other world events, we also have to resort to online communications for the time being.

The next Japan-Korea-Taiwan conference hosted by Dr Tamura that features case presentations by practitioners from different cultural backgrounds had also been postponed to July 2021 due to the pandemic.

REGIONAL COLLABORATIONS

In China, Prof Zhao Xudong, our Vice President, told us family therapy is now recognized in Germany by the Federal Joint Committee of Doctors and Health Insurance Companies (GBA) as an evidence-based approach. This is a big encouragement and model for all of us to pursue in our different regions.

We are pleased to announce that Prof Meng FU, who is also a member of our Accreditation Committee, had been appointed as the third Director of the Family Therapy Group of the Professional Committee on Psychotherapy Counseling of the Chinese Association of Mental Health (CAMH) in China. We hope she can continue to be instrumental in promoting family therapy in China in her new capacity.

In Korea, our Vice President, Prof Young-Ju Chun, informed us of the liaison between the Korean Association of Family Therapy, Korean Society of Narrative Therapy, Korea Association of Solution-Focused Therapy, and Korea Satir Transformational Systemic Therapy Association. The four associations co-hosted a conference titled, "Advancement of Relationship Science" on October 25th, 2019.

We are so excited to see so many regional and international collaborations taking place.

Becoming an AAFT Member

AAFT is the first academy established in Asia that aims to provide accreditation to family therapists practicing in Asia through its Fellow member category. Our membership categories are as follows:

Fellow Member Annual Fee: US\$210	An applicant who is interested in becoming a Fellow member should hold a graduate degree in the human services profession and have at least three years of post-graduate experience in working with families, including case practice, systemic training, and supervision. Fellow members of AAFT are our accredited clinicians. Therefore, their membership must be approved by the AAFT Vetting Committee, which is comprised of members representing Japan, Korea, Taiwan, Hong Kong, and Mainland China.
Full Member Annual Fee: US\$150	An applicant is eligible to become a Full Member if he/she has attained educational requirements for licensure or certification in the human services profession or equivalent. He/ She can pay a one-off membership fee to become a Life Member.
Associate Member Annual Fee: US\$110	Associate Membership is open to any applicant who holds a degree in other human service programs; or is a student in family therapy.
Student Member Annual Fee: US\$110	An applicant is eligible to become a Student Member if he/she is enrolled in a degree program in marriage and family therapy, human service programs, related mental health field, or equivalent.
Organizational Member Annual Fee: US\$520	Organizational membership is designed for professional or social service organizations/ associations/ societies/ institutions who share the mission of AAFT. Each Organization may nominate up to three members who will be eligible for AAFT membership.
